



## Luxe Event Rental LLC Inflatable Rental Waiver

### PLEASE ENSURE PROPER USE & SAFETY

THE INFLATABLE IS THE CUSTOMERS RESPONSIBILITY UNTIL RETURNED. CUSTOMERS AND OTHER PERSONS USING LUXE EVENT RENTAL LLC INFLATABLE BOUNCE HOUSE DO SO AT THEIR OWN RISK.

**For your information, safety and enjoyment we recommend the following:**

**Age Limit:** Our inflatables have an age limit of 14 years. Please ensure that no one over this age uses the inflatable especially adults. This is due to safety, manufacturing and insurance reasons.

**Adult Supervision:** A responsible adult must supervise children at all times while on the inflatable.

#### **Not Allowed:**

- Please do not allow anyone on the inflatable whilst inflating/deflating.
- Children are not allowed to climb, sit or hang on the inflatable walls.
- Do not allow children to bounce on the front safety step. The safety step is to assist users in getting on/off safely.
- Overcrowding. Ensure the inflatable is not overcrowded. Limit the number of users to allow enough room for each child to play safely
- Avoid small and large children using the inflatable at the same time
- All shoes, badges and jewelry must be removed
- We also recommend spectacles be removed
- No food or drinks to be consumed while on the inflatable to avoid both mess and possibility of choking
- No face paint, party poppers, colored streamers or silly string as these make a terrible mess and can also stain the inflatable for which you will be liable for payment to clean or repair.
- No smoking, fires or bar-b-ques to be used near the inflatable
- No pets to be allowed on the inflatable
- It is advisable to ensure that no one with any history of back or neck problems use the inflatable

#### **Safety Notices:**

1. Water fights are fun but do not spray water near the electric blower
2. Occasionally check that the inflatable is still securely pegged down
3. Never switch the blower on and off while the inflatable is in use

**IMPORTANT:** If the inflatable fails for whatever reason, evacuate immediately to prevent injury.

**IMPORTANT:** In the event of heavy rain or wind it is strongly recommended that the inflatable is switched off for safety reasons. When safe to re-use switch back on and towel dry any remaining wetness before allowing children back on.

\*Please remember if the inflatable is dirty or damaged when collected the renter is liable for the full repair, cleaning and or replacement costs.

On behalf of all children and adults in my care participating in activities at involving the inflatable bounce houses, I acknowledge and agree to the terms and conditions of this waiver as identified below:

1. There are risks, both known and unknown, using any inflatable or amusement device, including, but not limited to physical injury, emotional injury, distress, paralysis and even death. The risk of serious injury from participating in inflatable bounce house activities, although minimal, does exist, as it does in all play and amusement activities.

2. If the inflatable bounce house is being used outdoors, I take responsibility to make sure the bounce house is setup correctly. I will make sure to use all the stakes provided for grounding the inflatable bounce house, and make sure all safety tie downs are securely attached. If there are wind gusts up to 10 MPH, I will remove all individuals from the inflatable bounce house and deflate it to insure safety of all participants

3. I and the children and adults in my care who will participate in any inflatable bounce house activities are physically, mentally and emotionally fit to participate in such activities.

4. Should any children be dropped off in my care for use of the inflatable bounce house, I will inform them to follow all rules of participation and will trust their judgment or the judgment of my representative in their safe participation. I understand Taylor Rental staff does not provide a sitting service and is not responsible in their safe participation.

5. I, on behalf of myself, my children, my family members, children in my care, my heirs and my guests, knowingly and freely assume all risks of injury and agree to hold harmless Taylor Rental, Inc., its owners, managers, agents and employees with respect to any claims, demands, causes or rights of action, even if arising from the actions, acts of omission or negligence of said entities or individuals.
